

Open Access Policies of the Journal “Razón y Palabra”

Razón y Palabra is a journal that provides immediate open access to all its content, based on the principle that offering free access to research benefits users and institutions by fostering greater global knowledge exchange.

Aligned with the journal’s philosophy, *Razón y Palabra* promotes free dissemination to facilitate awareness of research in communication studies and related fields within the Ibero-American context. This allows anyone to read, download, copy, distribute, and print articles for free without prior permission from the editor or authors, as long as authorship is respected, and proper citation is given.

1. Objective:

The general objective of *Razón y Palabra*, a Communication journal, is the scientific dissemination of academic research in the field of communication studies. Therefore, “no fees are charged” for submissions considered by the editorial boards. Instead, the journal is open to discussion and the advancement of knowledge within the framework of defending human dignity.

2. Copyright:

Authors publishing in this journal agree to the following terms:

- Authors retain copyright and grant the journal the right of first publication. Their work will also be licensed under a Creative Commons Attribution License, allowing others to share the work with acknowledgment of authorship and the initial publication in this journal.

- Authors may enter into additional, non-exclusive agreements to distribute the published version of their work (e.g., posting it in an institutional repository or including it in a book), with recognition of its initial publication in this journal.
- Each article is assigned a DOI. Example: <https://doi.org/10.26807/rp>

3. Conditions Before and During the Submission and Publication Process:

Articles must be written according to the guidelines specified by *Razón y Palabra* and submitted via the ****Submissions**** tab in Word or Open Office formats (.doc, .docx, .rtf) after the author's registration.

Authors are encouraged to disseminate their work electronically (e.g., in institutional repositories or on their own website) before and during the submission process, as this can lead to productive exchanges and earlier, more significant citations of the published work (see The Effect of Open Access).

4. Readers' Rights:

Readers have the right to access and read all articles for free after their publication. For security reasons, authors can initially register only as readers and cannot upload any files. After registering as a reader, authors must email the *Razón y Palabra* Administrator to have their status changed to "author," enabling them to proceed with the submission process.

5. Machine Readability:

Full-text articles, metadata, and citations can be accessed and tracked with appropriate permissions.



Digital Preservation Policy of the Journal *Razón y Palabra*

Razón y Palabra is committed to high ethical standards and takes all possible measures to prevent fraud and plagiarism. The journal has implemented a digital preservation policy to ensure the continuous and long-term accessibility of its academic content. This is essential to safeguard its archives from potential losses due to technical issues, legal concerns, or changes in storage technology.

All authors must submit original, unpublished manuscripts of their authorship and declare these attributes when submitting their work for consideration by the editorial board. The journal is also committed to fair and objective manuscript review, employing a double-blind peer-review process.

Authors submitting their articles must comply with publication ethics, particularly regarding authorship, plagiarism of published articles, data manipulation, transparency in the publication process, conflicts of interest, and adherence to ethical research policies in accordance with the Committee on Publication Ethics (COPE): <http://publicationethics.org>

Razón y Palabra uses the Digital Object Identifier (DOI) for the identification and location of its articles, managed by CrossRef, ensuring article identification and preventing issues due to URL changes.

Definition of Open Access

Open Access refers to an international movement aiming to ensure that anyone with an internet connection can freely and without economic, technical, or legal restrictions access scientific, academic, and cultural information. Open Access is grounded in the BBB definition: Budapest (BOAI, 2002), Berlin (2003), and Bethesda (2003). It is commonly referred to as OA in English and AA in Spanish.

The *Razón y Palabra* journal operates under an open-access model, ensuring free availability on the public internet. This allows users to read, download, copy, distribute, print, search, or link to the full texts of articles. Users may use them for any research purpose without financial, legal, or technical barriers. The only limitation on reproduction and distribution concerns copyright, which ensures authors retain control over the integrity of their work and receive proper recognition and citation.

Open Access is compatible with copyright, as copyright remains with the authors and institutions that consent to make the published work openly accessible. Once an article is accepted, the author transfers publishing rights to the journal, granting it the prerogatives of an open-access publication. Open-access publications aim to maximize access while adhering to current copyright legislation and respecting the wishes of copyright holders.

Moreover, peer review aligns with Open Access and is essential to ensure the quality of publications. Open Access is free for both readers and authors.
